This is a deeply discounted season pass. It is not a traditional golf membership. The companies who find the most value in these passes have a lot of flexibility on when they play, especially the ability to play in the afternoons. It is recommended to log in the online booking engine often to get the most out of the pass. Golf tournaments and full-priced public rounds have priority booking. **TERMS AND CONDITIONS:**

**PRIVILEGES / BENEFITS:** Privileges for the 2026 golf season include up to the allotted number of tee times with cart included anytime Sunday through Friday and after 1:00pm on Saturdays. No holiday play. All golf is based on availability; 1 warm-up bucket of balls per player on the day of play when tee times are booked; You may book tee times up to 14-days in advance; Tee times are valid for 18-holes of golf with cart for up to 4 players only. Foursomes cannot be split up into different tee times or in to 9-holes; Golf shop, restaurant, and beverage cart discounts of 10% off (in-stock items only, excludes: alcohol, sale items, special offers, special dinners in the restaurant) for golfers on the day they play. Privileges cannot be used for or combined with tournaments, outings, promotions, or special events. Only the named representatives can book and cancel tee times. To book online, passholder must be logged in under their season pass profile and have selected the Corporate Category. All tee times expire December 31, 2026. Tee times cannot be carried over to subsequent years. To keep things equitable for all passholders, there are no exceptions to these conditions.

**NON-EQUITY ORGANIZATION:** Each Organization will be entitled to use the facility in accordance with the privileges granted by this agreement. Organization does not imply any right or privilege to participate in or to administer Thanksgiving Point Golf Club's business policies and does not create any ownership, vested or proprietary right of any kind in land, the facilities, or its assets.

**MANAGEMENT OF CLUB FACILITIES:** Thanksgiving Point Golf Club reserves the right to restrict or to otherwise reserve the club facilities for such purposes as the company deems appropriate including, without limitation, tournament play, maintenance, promotional activities, special events and 2 tee times per day. This includes golf course closure due to weather conditions and seasonality of weather conditions. **Please note, the club hosts several tournaments throughout the season and most often opens for regular play by 2:00pm on these days.**

**GENERAL CLUB RULES AND POLICIES:** Employees and guests of the Organization will be required to comply with any club rules and policies of Thanksgiving Point Golf Club set forth herein or otherwise implied hereafter. Any Organization who violates this agreement or otherwise engages in conduct detrimental to Thanksgiving Point Golf Club is subject to revocation of their Season Pass and all associated privileges without refund. Organization is responsible for their employees' and guests' conduct and behavior.

**CHECK-IN:** All employees and guests of the organization must check-in in person inside the golf shop a minimum of 10 minutes prior to the scheduled tee time or the tee time will be forfeited and the organization will still be charged for the tee time.

**CANCELLATION POLICY:** Organization will be held responsible for any tee times not canceled or changed prior to 48-hours before the tee time. Repeated violations will lead to suspension of privileges and potential revocation of Season Pass and remaining tee times without refund.

**RULES AND REGULATIONS:** Organization agrees to abide by the club rules and regulations while in the club facility. These rules and regulations may change from time to time in the discretion of Thanksgiving Point Golf Club. Failure to abide by the club rules and regulations may result in termination of Season Pass.

**LIABILITY & DAMAGES:** Organization accepts responsibility for all property damages; including golf carts (except due to ordinary wear and usage) caused by themselves or their guests. The club shall not be liable to Organization or their guests for property damaged, lost, or stolen in or about the club and the Organization hereby releases Thanksgiving Point Golf Club from any such loss. Organization assumes all risks and hazards, now or in the future, whether known or unknown, arising out of or connected with the Event or this Contract, to the extent caused or contributed to by the negligence of the Organization or Organization's guests, invitees, employees, independent contractors, agents, or representatives, and hereby agree to forever waive, release, discharge, indemnify, and hold harmless the Club and Troon, as well as each of their respective owners, principals, affiliates, directors, officers, agents, employees, representatives, successors and assigns, and any other parties acting on their behalf (collectively, the "Released Parties") from any and all claims, liabilities, damages, expenses and costs, including, but not limited to, attorneys' fees and costs arising out of or in connection with any illness, personal injury, death, or property damage claims, whether or not adjudged to be foreseeable, which may now or hereafter be brought against the Release Parties. Organization further acknowledges and agrees that the foregoing covenants are contractually binding, are not mere recitals, and that should Organization or Organization's guests, invitees, employees, independent contractors, agents, or representatives assert any claim in contravention of this Contract, the asserting party shall be fully liable for the expenses and costs, including legal fees, incurred by the Released Parties.

**REFUND / POLICY CHANGES:** The club does not refund Season Passes under any circumstances. The club reserves the right to change fees, services, and operational procedures without prior notice to the Organization.

**SUSPENSION AND TERMINATION:** At the sole discretion of the club management, an Organization who is in arrears in their account to the club may be suspended or terminated. Use of the club facility is available to Organizations in good standing and their guests. The club may terminate an Organization's pass by notification in writing, at the last address shown on club records for that Organization. A terminated Organization will remain liable for all indebtedness incurred.

**SEVERABILITY:** In the event any part or parts of this agreement are determined invalid or unenforceable, such part or parts shall be severed and their remainder shall be in effect.

**GENERAL:** This agreement may not be assigned or otherwise transferred, in whole or in part, by the Organization. In the event that Thanksgiving Point Golf Club commences any action to recover amounts due from the Organization, it shall be entitled to recover its attorneys' fees and costs. No provision of this agreement may be waived, unless such waiver is in writing. No waiver in any one instance shall be effective in any other instance. The fact that one party or the other party drafted this agreement shall not be considered in the interpretation of this agreement. The obligations of an Organization to Thanksgiving Point Golf Club shall survive any termination or cancellation of this agreement.

**GOVERNING LAW:** This Contract shall be governed by and interpreted in accordance with the laws of the State of Utah without regard to is conflict of law rules. The Organization and the Club further consent to and agree upon exclusive jurisdiction and venue in either the federal courts sitting in a United States District Court in the State of Utah, unless no federal subject matter jurisdiction exists, then in the Superior Court of the State of Utah.

**AGREEMENT:**

Application is subject to approval by Thanksgiving Point Golf Club and shall be effective only when Thanksgiving Point Golf Club approves this agreement. The undersigned states that he/she has read and understands the Terms and Conditions of this agreement and is an authorized representative of the organization; agrees to be bound by such Terms and Conditions and acknowledges that he/she has received a copy of this Agreement. Any account balances must be paid in full prior to termination.

Acceptance and approval by Thanksgiving Point Golf Club constitutes a contract between the parties granting the Applicant all rights and privileges afforded to the applicable Organization under the current Terms and Conditions. Rules and Regulations, Terms and Conditions and the General Terms and Conditions may be amended from time to time at Thanksgiving Point Golf Club's discretion. Thanksgiving Point Golf Club reserves the right to cancel any Season Pass in part or in full with or without cause.

The provisions of the Terms and Conditions and the General Terms and Conditions are hereby incorporated in this Agreement. Each party has read this Agreement and understands the contents thereof. Signature below indicates that there are no questions about the terms of this Agreement and the obligations of the parties and the Organization intends to be bound hereby.
